

IMPORTING YOUR PET

Upon arrival of your animal, U.S. Customs and Border Protection (CBP), USDA, the Center for Disease Control, and often the Fish & Wildlife Service and APHIS may all require notification. Each of these agencies has the right to hold your animal until all of their requirements have been met. Coppersmith Global Logistics works on your behalf to file the information that you provide, in a format satisfactory to the agency. Original documents are required and release times will vary depending on species and workload in each individual port of arrival.

We are here to help. Coppersmith Global Logistics is a Licensed Customs Broker who works under power of attorney, to arrange for the clearance of your pet through the U.S. governmental regulatory agencies. We are not a carrier, handling agent, or government agency and have no contact with your animal. We only handle documentation and at no time are we responsible for the physical handling, location, disposition, release, or well being of your animal.

REQUIRED IMPORT DOCUMENTS

Owner/Breeder/Importer

The following documents are needed from you, 24 hours prior to your pet's arrival into the U.S.A. All documents must be in English, valid, and **legible**. Some forms can be found on our website.

- Power of Attorney: signed by consignee, showing IRS# or Social Security Number
- U.S. Government issued Identification: Drivers License, Passport or Visa
- Foreign Importer (non-US citizen): Coppersmith can apply for a Customs Assigned Number for you.
 In this situation, please show your *foreign address* on the Power of Attorney.
 Proof of identity is required

Pet/Animal

Entry into the United States requires the following documents regarding your animal. Documents must show your pet's name, date of birth, gender, species, and breed.

- Invoice for Customs purpose—showing description, ownership, value (proforma available on website)
- Health Certificate, Rabies Certificate, Vaccination Card and any other pertinent documents.
- Airline Air Waybill

Note: Dogs must be at least 4 months of age to be imported as personal pets, and no less than 6 months old for resale with appropriate **Permit**. All dogs are required to have been immunized for rabies unless originating from a rabies free country. See list of countries: https://www.cdc.gov/importation/rabies-free-countries.html Animals appearing sick or without proper permits or health certificates may be detained and quarantined, or refused admittance and exported at owner's expense. Coppersmith handling fees still apply.

Memorandum of Understanding

This memorandum of understanding is entered into by the pet owner or importing party responsible for the animal. As such, I enter into this agreement of my own free will and affix my signature to this MOU as confirmation of my understanding and agreement.

I authorize L.E. Coppersmith, Inc., doing business as Coppersmith, Inc. and Coppersmith Global Logistics (LEC), a licensed customs broker, to act on my behalf to handle the governmental documentation formalities required to obtain release of my pet from Customs and Border Protection and any other governmental regulatory agency.

I understand that I can personally handle the governmental requirements to release my pet, yet I am assigning LEC to provide this service, as evidenced by my signed Power of Attorney.

I understand that I am solely responsible to provide all required documentation necessary for LEC to file the governmental entries to obtain release of my pet. (Including all veterinary/health certificates, commercial invoices, age certifications, as well as my personal identification forms and social security number, as required by law).

I understand that at no time is LEC responsible for the physical handling, health, care, well-being, or death of my pet. I further agree to hold LEC harmless from any legal actions that may result from the mishandling, injury, or death of my animal.

I agree to pay LEC for any and all services provided, whether or not they complete the release of the animal. I further agree to reimburse LEC for all outlays and service fees incurred by LEC while acting on my behalf. (Including but not limited to; freight, transportation, examination, storage, boarding, veterinary services, refusal, and/or return fees).

I understand that LEC is acting solely as an agent, on my behalf, and that they have no control over the acceptance, release, or refusal of the animal I am attempting to import. I further agree to LEC's standard terms and conditions as shown on their website www.coppersmith.com.

NOTE: Per CODE OF FEDERAL REGULATIONS (CFR) Title19-1-111.29(b): "If you are the importer of record, payment to the broker will not relieve you of liability for Customs Charges (duties, taxes, or other debts owed to Customs) in the event that the charges are not paid by the broker. Therefore, if you pay by check, Customs charges may be paid with a separate check payable to the "U.S. Customs and Border Protection", which shall be delivered to Customs by the broker." If you wish to make your check payable directly to U.S. Customs and Border Protection, arrangements must be made with Coppersmith, Inc. prior to time of entry to arrange timely receipt of your duty check. When payments are made to Coppersmith Inc., Coppersmith Inc. may undertake any means of payment to Customs available to them under current laws and regulation.
